

Auramix 450



High performance admixture for low fines and free flow concrete with low stickiness.

Uses

Auramix 450 is a high performance superplasticiser intended for applications where high water reduction and long workability retention are required, and it has been developed for use in:

- Self-compacting concrete,
- Rheology of concrete will help to pump greater heights with less thrust on pump
- Shear wall and retaining wall concreting.
- High performance concrete.

Standard Compliance

Auramix 450 complies to IS 9103 - 1999 (2013) and ASTM C 494 Type F and G depending on dosage.

Advantages

- Low viscosity suitable for pumping of different grades of concrete to higher floors
- Improved adhesion to reinforcing and prestressing steel

Description

Auramix 450 is a unique combination of the latest generation superplasticisers, based on a polycarboxylic ether polymer with long lateral chains. This greatly improves cement dispersion. At the start of the mixing process an electrostatic dispersion occurs but the cement particle's capacity to separate and disperse. This mechanism considerably reduces the water demand in flowable concrete.

Auramix 450 combines the properties of water reduction and workability retention. It allows the production of high performance concrete and/or concrete with high workability.

Dosage

The optimum dosage of Auramix 450 to meet specific requirements should always be determined by trials using the materials and conditions that will be experienced in use. The normal dosage range is between 0.5 to 2 kg.0 ltrs/100 kg of cementitious material.

Use at other dosages

Dosage outside the normal range quoted above can be used to meet particular mix requirements. Contact Fosroc for advice in these cases.

Effects of overdosing

Overdosage may cause delay in the setting time and segregation.

Estimating

Packaging

Auramix 450 is supplied in 200kg, 250kg and Bulk.

Storage

Auramix 450 has a minimum shelf life of 12 months provided the temperature is kept within the range of 5°C to 50°C. Should the temperature of the product fall outside this range then contact local Fosroc office for advice.
