Water reducing and retarding type concrete admixure.

Uses

- To produce pumpable concrete
- To produce high strength, high grade concrete M40 and above by substantial reduction in water resulting in low permeability and high early strength.
- To produce high workability concrete requiring little or no vibration during placing.

Advantages

- Improved workability Easier , quicker placing and compaction.
- Increased strength Provides high early strength for precast concrete if water reduction is targetted.
- Improved quality Denser, close textured concrete with reduced porosity and hence more durable.
- Chloride free Safe in prestressed concrete and with reinforced concrete.

Standards compliance

Conplast SP430A1 complies with IS:9103:1999 and BS:5075 Part 3 and ASTM-C-494 Type 'G' as a high range water reducing admixture.

Description

Conplast SP430A1 is based on Sulphonated Napthalene Polymers and is supplied as a brown liquid instantly dispersible in water.

Conplast SP430A1 has been specially formulated to give high water reductions upto 25% without loss of workability or to produce high quality concrete of reduced permeability.

Properties

Appearance	Brown Liquid
Specific gravity	1.240 to 1.260 at 27°C
Air entrainment	Typically less than 2% additional air is entrained at normal dosages.

Compatibility: Can be used with all types of cements except high alumina cement. Conplast SP430A1 is compatible with other types of Fosroc admixtures when added separately to the mix. Site trials should be carried out to optimise dosages

Workability: Can be used to produce flowing concrete that requires no compaction. Some minor adjustments may be required to produce high workability mixes without segregation.

Cohesion: Cohesion is improved due to dispersion of cement particles thus minimising segregation and improving surface finish.

Compressive strength: Early strength is increased upto 40% if water reduction is taken advantage of. Generally, there is improvement in strength upto 20% depending upon W/C ratio and other mix parameters.

Durability: Reduction in W/C ratio enables increase in density and impermeability thus enhancing durability of concrete.

Application instructions

Dosage

The optimum dosage is best determined by site trials with the concrete mix which enables the effects of workability, strength gain or cement reduction to be measured. Site trials with Conplast SP430A1 should always be compared with mix containing no admixture. As a guide, the rate of addition is generally in the range of 0.6 - 2.0 % by weight of cement.

Use at other dosages

Dosages outside the normal range quoted above can be used to meet particular mix requirements. Contact Fosroc for advice in these cases.

Effect of overdosage

An overdose of double the recommended amount of Conplast SP430A1 will result in following:

- Increase in air entrainment
- Increase in workability
- Retardation of initial and final setting times.

However, If the concrete is properly cured, the ultimate strength of concrete will not be adversely affected and will generally be higher than normal concrete.

Dispensing

The measured quantity of Conplast SP430A1 should be added along with the gauging water. For best results, add Conplast SP430A1 in the last phase after prewetting the mix with 80% of the total water required.

Mix design

Packaging

Conplast SP430A1 is supplied in 200kg, 250kg and bulk supply.

Storage

Conplast SP430A1 has a minimum shelf life of 12 months when stored under normal temperatures. It should be protected from extreme temperatures and preferably stored in shade.

Precautions

Conplast SP430A1 is non-toxic. Any splashes on the skin should be washed immediately with water. Splashes to the eyes should be washed immediately with water and medical advice should be sought.
